Toronto being named the best city in the world in which to live and work by Fortune Magazine (see over), spurred a gleeful gloatfest from local politicians.


Wait a minute!

A toast to all of you!


And, let's be fair, thank you to the enlightened and devoted politicians who did help.



If planning report is adopted by Councillors

Base of Spit still in jeopardy to industrial development

The City of Toronto Planning Department recommends maintaining the existing industrial zoning on the part of the Spit baselands where the "Golf Academy" was to be located and not the rezoning of the area to Gr (conservation lands), as was requested by Toronto City Council on May 21. The City staff still thinks projects such as the "Golf Academy" or industrial uses are desirable for this area, in spite of the fact that all Councillors voted for a rezoning to Gr.

> The report says that the <u>12 hectare</u> parcel that City Council requested to be rezoned Gr:

• Does not have significant natural and environmental attributes

Is not an important habitat for wildlife

Is an unattractive wasteland

• Is not needed for the continued existence of the wildlife in the area (continues over)

Golf driving range... back on the agenda? (cont'd)

It is up to you to contradict these assertions.

Indeed, the MTRCA (Metro Toronto and Region Conservation Authority) has identified the site as part of an ESA (environmentally significant area) encompassing the entire North Shore Park and Base of the Spit, due to the existence of a mix of habitats along with regionally rare plant species. (The City staff counters that these species are also found elsewhere in the Port!)

The City staff also claims that "many of the objections to the golf academy proposal referred to the protection of the entire Leslie Street Spit and the Base of the Spit which are already designated and protected as Natural Area or ESA in the Official Plan". Of course, because the people who wrote the letters know that the Spit is the sum of its parts and that its viability and diversity as a wildlife habitat and its attractiveness as a public park require a large landmass, of which the site in question is a critical part.

It is up to you to make that point!

#### Friends of the Spit's position

Our group advocates that the entire Spit, including the whole of the baselands south of the present alignment of Unwin Avenue (see map over), should be designated as conservation lands, for wildlife habitat and "passive" recreation.

It is a proactive and positive position, in view of the increasingly large (huge?) number of people who come to the area for a diversity of leisure activities. Industry

The report claims that the 12-hectare site is critical to the city's industrial strategy and that millions in revenues would be lost if it is not used for industry. This kind of scaremongering calculations leave us quite sceptical, given that there is adequate space on other parts of the Port lands (north of Unwin Avenue) and at the site of Ataratiri. WE NEED YOUR HELP. Come to the Land Use Committee meeting and bring your friends (numbers <u>do</u> count). Write to your Councillor and to the Mayor, reminding them of their commitment in May, and ask your friends to do so. Post a notice on Internet sites.

The full text of the planning report (16 pages) is available at City Hall, from Land Use Committee Clerk. Title is: Report on Areas of Environmental Significance or Interest in the Port Area south of the Ship Channel.


### Spit helps boost Toronto to #1


#### November 1996

On May 21, when City Council voted unanimously to reject plans for a Golf driving range on the Spit baseland and to rezone the area Gr (conservation lands), it was hailed as a great victory for citizens. Unfortunately, that victory may be only of short duration. The City Planning staff recommends maintaining industrial zoning on that part of the baselands.

Here's the win: the nutty idea of a driving range on the Leslie Spit has been shat upon

mightily from ahigh at Toronto City Hall. A driving range is an ecological dead

zone whipped by a hailstorm of golf balls, the ground soaked with poisons and shaved relentlessly to keep it "trim."

The argument used by The Proponents, as the hustlers are always called, was that the area where they wanted to hack out a driving range "wasn't part of the spit." It was to be located between the First Gate, at Unwin Ave., and the Second Gate, just beyond the meadow and before the embankment begins.

Technically, the spit doesn't begin until the Second Gate, you see. It had been zoned differently --- as if ecosystems, even interesting, evolving new ones like the spit's, had precise borders, like municipalities.

#### In reality, the meadow and young forests that have grown up in the space between Unwin and the Toronto Harbour scrub and immature woodlands taking Commission marina are every bit as much a part of the spit bioregion as the ponds and the cottonwoods out by the lighthouse where the redwing blackbirds are nesting in the tall grass.

The spit has a special place in the hearts of Toronto-area birders, hikers, joggers, inline skaters, bicyclists and wildlife lovers. Planned in the '50s as a breakwater for a superport for increased Great Lakes shipping that never materialized, the barren pile of rubble from office tower excavations, demolition and street repairs has become our Paradise Regained.

Its spine is a layer of concrete, brick and other construction material with silt and sand dredged from the bottom of

Lake Ontario piled on top, forming beaches and wet meadows, with mixed root.

Io home for the range

The five-kilometre peninsula serves as a showcase tor spontaneous ecological regeneration. Seeds blew or washed over from the Toronto Islands, or else were carried by birds and animals. The landfill being dumped there contained enough life itself, no doubt, to trigger its own eventual restoration, but the combination of nature and industry fashioned something astonishingly rich.

Displaced from other natural wetlands, marshes, swamps and meadows (sometimes, indeed, by driving ranges) the migratory birds that still pass through

the Toronto area took to the new resting grounds with an eagerness born of desperation. And it looks like they'll be able to carry on. Hurray!
