**SAILORS TO GET PERMANENT LEASE**

*Shortly to be ratified by Toronto City Council, the sailing clubs will be granted the use of portions of the North Shore, in the vicinity of Cherry Beach, "for community non-motorized boating operations. The security of tenure that the sailors have sought for so long is now available to them on north-shore parkland.*

THEREFORE, THE MTRCA NO LONGER HAS ANY REASON FOR INCLUDING SAILING CLUBS IN ITS MASTER PLAN. NOW THE SPIT CAN BE LEFT TOTALLY NATURAL.

The pressures that the sailing clubs in their desire for a permanent home placed on the politicians can now be solved - the politicians can have it all ... home for the sailors on the north shore - and a public urban wilderness for the entire Spit.

Now, we ask: **WHEN DOES URBAN WILDERNESS GET PERMANENT STATUS?**

**WATERSHED - AN IMPORTANT MILESTONE**

*Watershed, the second interim report of the Crombie Commission, issued in September, made a number of broad recommendations on the future of the Toronto waterfront. The report accomplished two things of importance to Spit-lovers...*

First, the report tackles the Toronto Harbour Commission (THC) head-on, and makes many recommendations to redefine and redirect the THC. A large number of deputies to the Crombie Commission, Friends of the Spit included, stated that the THC should be a port authority only (that is to have its jurisdiction limited to the operation of the commercial shipping port). In fact, the Royal Commission goes as far as to specify which port lands should remain with the THC, and to recommend that the remainder be transferred!!!

The second major item of the report for us shows that all land south of Unwin Avenue becomes parkland!!!

The report further states that the Outer Harbour Marina (also known as "the THC marina") should be conveyed to the City, limited to the existing 400 slips. A continuous water promenade is also recommended.

**While we are on record as opposing the Outer Harbour Marina in any shape, size or form, the rest of the recommendations are substantially those that we wish.**

And, happily, the City of Toronto has endorsed Watershed.

**OUTER HARBOUR MARINA - OMB APPEAL**

*As you may remember, May 1990 would have seen the Ontario Municipal Board (OMB) hearing the appeal against the City of Toronto zoning amendment which permitted 400 berths at the Outer Harbour Marina.*

This hearing was adjourned, pending discussion between the parties involved. At our Annual General Meeting, the membership adopted a resolution that the steering committee continue to pursue its negotiations with the parties involved, in the hope that satisfactory resolution could be achieved without going to the OMB. At the time of this writing, negotiations have taken place; however, nothing has been finalized.

**Discussions taking place**

The THC had proposed to accommodate sailing clubs on the marina arm, while retaining the right to at least some of the existing berths. The Metro Toronto and Region Conservation Authority (MTRCA) had agreed to an adjournment of its Environmental Assessment application for its Master Plan for the Spit pending discussions between the City of Toronto and the THC, to find a permanent home for the sailing clubs. While these discussions were proceeding, the Watershed Report was issued.

Again, at this writing, there has been no resolution.

**TRAIL ALONG WATERFRONT**

*Among the recommendation of the Crombie commission is a Greenspace Trail along the waterfront.*

Already, a volunteer committee has been formed by environmental and citizens groups, to make it happen. One of our members is representing Friends of the Spit on the Ad Hoc Committee on the Waterfront Trail. Our thanks to Boris Mather for being our rep.

**TRIANGLE LANDS - THC PROPOSES "INDUSTRIAL" USES IN 6-STORY BUILDINGS**

*Despite the recommendations of Watershed, the Toronto Harbour Commission is still attempting to proceed to subdivide the triangle lands, at the base of the Spit, for a "business park".*

This plan has been soundly criticised by many parties. The City's own planning staff has recommended that Toronto City Council discontinue the processing of the THC application. For our part, we have made several deputation to the City, to the effect that there should be no subdivision, and that, at the very minimum, the entire area south of Unwin Avenue should become public open space.

Our position corresponds to the recommendations of the Crombie Commission in its Watershed report.

Last December, a sub-committee was established by the City of Toronto to deal with this land. No report has yet been made available.

**CELL ONE CAPPING PROPOSAL**

*Cell one - that is the first of the lagoons you see on the east side of the Spit as you go towards the tip - is nearly filled with dredgeate from the Keating Channel. As required under the Keating Channel Environmental Assessment, the MTRCA must cap this cell.*

At a meeting of the Natural Area Advisory Committee, in January, the MTRCA told the Friends of the Spit representative that the dredgeate in the cell appeared to be far less contaminated than had been originally feared, and that the dredged material met the criteria for recommissioning of land for park purposes.

**Marsh habitat could be possible**

The MTRCA is proposing a scheme whereby the dredgeate would be capped with clean fill, and a number of islands created. This would allow a marsh habitat, consisting of year-round water, flooded areas and solid land.

Provided that the analysis of the contaminants continues favourably (a number of concerns have been raised in this respect), and that the Ministry of the Environment accepts the MTRCA capping proposal, Friends of the Spit feels that it would go a long way toward satisfying our request to return marshland to an area that was once 1000 acres of wetlands, at Ashbridges' Bay.

**CONFUSING FALCONS**

*Through December, many observers reported seeing a dark-faced Gyr Falcon at the Spit. However, during the Annual Christmas Bird Count, which took place at the Spit on December 23, this dark phase bird was identified as a Peregrine Falcon, with leg bands identifying it as a release from one of the Canadian breeding programmes.*

For members who are birders, this confusion and controversy will continue for many months. From our viewpoint, a local Peregrine isn't shabby, so why complain!!

## TERN RAFTS SUCCESSFUL

*In its Tommy Thompson Park Newsletter of October, 1990, the MTRCA reports that the tern rafts you saw placed in Embayment D and in Cell One were successful.*

In total, terns built 128 nests and laid 361 eggs. The MTRCA estimates that between 150 and 200 young terns fledged! This certainly helps the Common Tern population.

The MTRCA plans to continue this program in 1991, in cooperation with the Canadian Wildlife Service.



## VIEWING DAY 1991 ? - MAYBE

*For three years in a row, starting in 1988, Friends of the Spit has held very successful "Viewing Days" at the Spit on the first Sunday in June, with the assistance of a grant from Environment Canada.*
